

# 2019-2020 VERIFICATION WORKSHEET

## Federal Student Aid Programs



Your 2019–2020 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, Toccoa Falls Financial Aid Staff will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. **You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Toccoa Falls Financial Aid Office.** If you have any questions about verification, contact the Financial Aid Office as soon as possible in order to avoid a delay in receiving your financial aid award.

**NOTE: WE CANNOT ACCEPT A SIGNED COPY OF THE TAX RETURN.** If the student and/or parent did not use the IRS Data Retrieval Tool when completing the FAFSA, the student and/or parent **must submit an IRS Tax Transcript, OR go back into the FAFSA and use the IRS Data Retrieval Tool** to complete the FAFSA 2017 tax information. **Tax Filing Extensions:** If the student and/or parent is required to file income taxes for 2017, but obtained an extension, the student and/or parent must submit an IRS form 4868 or IRS approval to extend beyond October 15, 2018 and a W-2 for each source of employment. If self-employed, a signed statement must be submitted certifying the amount of the AGI (adjusted gross income) and U.S. income tax paid for 2017. When taxes are filed, an IRS Tax Transcript must be requested from the IRS and sent to the school to re-verify the AGI and taxes paid.
