



## Dual Enrollment Registration Instructions

### 1. APPLY FOR STATE FUNDING

Each semester, ensure that you have completed and submitted the online Dual Enrollment Funding Application at [GAFutures.org](http://GAFutures.org). This step must be completed once per school year, so you may have already submitted your funding application—be sure to check before assuming! Additionally, you need to make sure that you have added “Toccoa Falls College” to your funding application. This step will not be complete until your parent/guardian has submitted the Parent Participation Agreement sent to their email address.

Completing this application does not automatically register you for classes, but is **required** before you can be registered. This is the only way for you to receive funding for your selected courses!

### 2. PICK YOUR CLASSES

Each semester, fill out the TFC Dual Enrollment Registration Packet after you have met with your High School Guidance Counselor/Homeschool Official to determine which classes are right for you. This packet contains two forms: The Funding Acknowledgments Form and the Registration Form, found in this document. **Both** forms must be completed and submitted before you can receive a schedule!

### 3. SUBMIT TO TFC

Once your forms have been signed, submit them to the Dual Enrollment Office at [dualenrollment@tfc.edu](mailto:dualenrollment@tfc.edu). If you’re missing anything, we’ll let you know!

### REGISTRATION CHECKLIST

- Submit a GAFutures Funding Application for the appropriate year/term; don’t forget about the Parent Participation Agreement
- Meet with your High School Guidance Counselor/Homeschool Official to record which courses are best for you and ask them to sign the form
- Ask your parent/guardian to sign both the Funding Acknowledgments Form and the Registration Form

## Who is eligible to receive state funding?

- 9<sup>th</sup> grade students are not eligible.
- 10<sup>th</sup> grade students\* are *only* eligible with a minimum SAT score of 1200 or minimum ACT composite score of 26 in a single national test administration AND a minimum of a 3.7 unweighted GPA.
- 11<sup>th</sup> and 12<sup>th</sup> grade students are eligible, assuming the funding cap has not been exceeded (see below).
- Any student who attends high school outside of the state of Georgia is not eligible to receive state funding.

*\*This limitation is set by GAFutures. 10<sup>th</sup> grade students can be accepted to Toccoa Falls College without test scores, but the understanding is that these students will pay out of pocket for all courses until their 11<sup>th</sup> grade year.*

## What are the limits on the state-funded Dual Enrollment funding program?

- The Dual Enrollment Funding Cap is 30 semester hours, taken with any postsecondary institution.

## Can a student retake or withdraw from a Dual Enrollment course?

- Effective Summer term 2020, a student may not receive funding for the same course twice. Courses taken Summer term 2020 or later cannot be retaken and receive funding.\*
- Effective Summer term 2020, students became ineligible to continue to receive Dual Enrollment funding after their 2<sup>nd</sup> course withdrawal.

*\*This includes courses that a student has withdrawn from.*

## Can a student take Dual Enrollment courses at Toccoa Falls College if they are ineligible to receive funding?

- Students who have exhausted funding eligibility or are ineligible to receive funding may choose to self-pay for additional credit hours/courses at the discounted tuition rate of \$250 per credit hour\* + the cost of textbooks.

*\*You can tell how many credit hours a course is worth by looking at the last digit of the TFC Course Code. If you're not sure, you can always ask!*
