HEERF - Emergency Financial Aid Grants to Students – 03/31/2022

1. Toccoa Falls College signed and returned the Certification and Agreement to the Department of Education on July 22, 2020. Toccoa Falls College received a Grant Award Notification of additional Emergency Financial Aid Grants to Students as part of HEERF from the Department of Education on May 24, 2021. Toccoa Falls College has used and will use these funds to provide Emergency Financial Aid Grants to Students.
2. The amount that Toccoa Falls College was awarded for HEERF from the Department of Education pursuant to the original Certification and Agreement for Emergency Financial Aid Grants dated May 24, 2021, is...
 - a. HEERF I – CARES ACT: \$240,620
 - b. HEERF II – CRRSAA: \$240,620
 - c. HEERF III – ARP: \$974,072
 - d. TOTAL HEERF Funds Awarded: \$1,455,312

- b. HEERF II – CRRSAA: based upon Title IV eligibility as evidenced by a completed and verified FAFSA, residential status and the amount of Pell awarded.
 - c. HEERF III – ARP: for the first disbursement was to provide grants to students with an Expected Family Contribution of \$0 on the 2020-2021 FAFSA who also received a Pell Grant in the Summer 2021 academic term based on their enrollment level for the Summer 2021 academic term.

HEERF I – CARES Act: monthly updates on the status of the letter from the U.S. Department of Education confirming that the College is entitled to receive the funding without waiving the College's free exercise and constitutional rights under applicable religious exemptions contained in nondiscrimination statutes referenced in the grant application documents, the quarterly/annual reports and the email message sent to recipients of the funds informing them of their eligibility for the Emergency Financial Aid Grants and information regarding the date, time and location for the them to pick-up the HEERF Grant disbursement checks.
 - b. HEERF II – CRRSAA: an email message sent to recipients of the funds informing them of their eligibility for the Emergency Financial Aid Grants and information regarding the date, time and location for the them to pick-up the HEERF Grant disbursement checks.
 - c. HEERF III – ARP: an email message sent to recipients of the funds informing them of their eligibility for the Emergency Financial Aid Grants, the options for receiving the funds, and the date that the HEERF Grant disbursement checks would be mailed or posted to the student account for those students electing this option.
